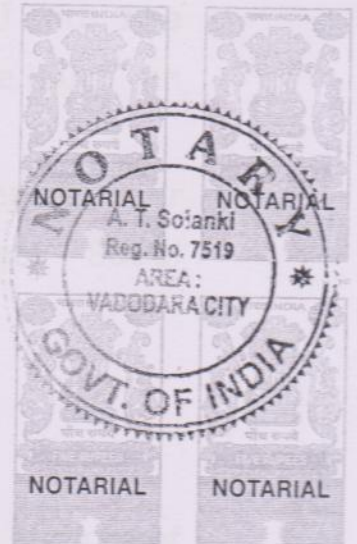

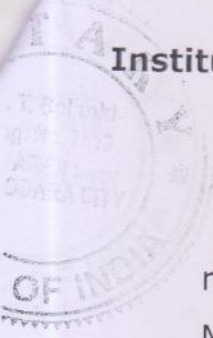

## MoU for Clinical Exposure/Training of Students from BITS

### Institute of Physiotherapy (BIPT) at Sunshine Global Hospital (SGH), Vadodara.

Sunshine Global Hospital (130 bedded), Vadodara (hereafter referred to as "**The Hospital**") is located at Manjalpur Road, Manjalpur, Vadodara.

BITS Institute of Physiotherapy (hereafter referred to as "**BIPT**") is a college at BITS Edu Campus, Varnama, Vadodara affiliated with Gujarat University and Shree Govind Guru University. **BIPT** offers Bachelor of Physiotherapy (B. Physio) Programme since the academic year 2014-15.

For the clinical training / exposure of the students pursuing this programme, **BIPT** intends to enter into an academic MoU with **The Hospital**. Both the organizations have agreed to have such an academic MoU in the mutual interest.

This MoU would facilitate both the parties to realize their Academic Social Responsibility (**BIPT**) and Corporate Social Responsibility (**The Hospital**).

### Terms of Agreement

1. The agreement entered by both the parties is only with sole purpose of "Sharing clinical resources for Teaching - Learning purposes".
2. **The Hospital** agrees to have an academic MoU with **BIPT** to the extent of educational support in the form of clinical exposure and clinical training to the students. This will include access to the facilities like treatment procedures, methods and medical records necessary for Teaching-Learning of **BIPT** students.
3. **BIPT** shall pay Rs. 500 per student per 15 day to **The Hospital** for utilizing clinical resources for Teaching - Learning purposes.
4. At least one (1) Physiotherapy faculty of **BIPT** will accompany the batch of their students posted in **The Hospital**.

5. This agreement shall remain in force for the next 11 Months i.e. Dec 2019 to Oct 2020. It can be further extended by mutual consent, either in the present form or any modifications as the need be.



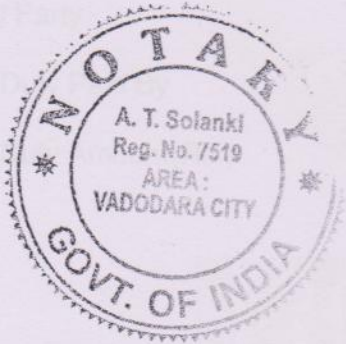
