MEMORANDUM OF UNDERSTANDING
BETWEEN

("A DIVISOR OF NIRMAN ORTHOPEDICS PVT LTD")

PREAMBLE:

Viroc Super Speciality Orthopedic Hospital "A DIVISOR OF NIRMAN ORTHOPEDICS PVT LTD", Vadodara (hereafter referred to as "**The Hospital**") is located at Arya Kanya road, Karelibaug, Vadodara.

BITS Institute of Physiotherapy (hereafter referred to as "**BITSP**") is a college at BITS Edu Campus, Varnama, Vadodara affiliated with Gujarat University and Shree Govind Guru University. **BITSP** offers Bachelor of Physiotherapy (B. Physio) Programme since the academic year 2014-15.

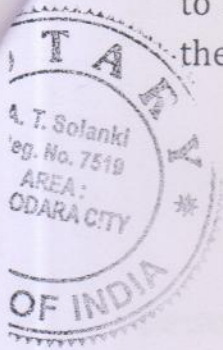

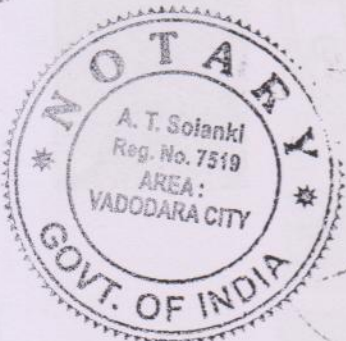
